- Name

- Product-related information (e.g., order or arrival status)

This information is used solely for:

- Scheduling an eye exam
- Confirming or updating appointments
- Sending notifications when ordered products are ready for pickup

#### Data Sharing Disclosure

Your mobile information and opt-in consent will not be shared with third parties or affiliates for marketing or promotional purposes. This includes no selling, renting, trading, or unauthorized transfer of your mobile number.

Information may only be shared when required to deliver the messaging service (e.g., via your wireless carrier) or when required by law.

Message and data rates may apply, depending on your mobile carrier plan.

#### Message Frequency

You will receive no more than 10 messages annually related to online exam scheduling and appointment/product-related updates.
